The contract period will be 14 Weeks.

- 1. Bidding will be conducted through National Competitive Bidding Procedure.
- 2. To be eligible for the contract award, the successful bidder shall not have been blacklisted.
- 3. Qualification requirements to qualify for contract award include
  - Average annual value of construction work performed in last five years shall be at least Rs 60.0 million.
  - The minimum amount of liquid assets and /or credit facilities (after setting apart for other contractual commitments) and exclusive of any advance payment which may be made under this Contract, shall be not less than Rs 2.0 million.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to Department of Government Information, 163, Kirulapone Ave, Colombo 05 from 06/07/2018 until 26/07/2018 from 0900 hrs to 1500 hrs during a working day upon payment of a non-refundable fee of Rupees 2500.00 The method of payment will be in cash.
- 6. Bids shall be delivered to the address below or shall be deposited in the Bid box placed in the below address on or before 11.00 hrs on 30/07/2018. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
